SALE CONTRACT AND HEALTH GUARANTEE

Option 1 - LIFETIME Health Guarantee - Should you choose this offer, the lifetime guarantee stipulates that the puppy must be fed Life's Abundance All Stage and Agility Formula for their entire lifetime. We recommend The Agility Formula be given starting when the puppy is 6 months old. The reason we have chosen to offer this option to our guarantee, is because so many dogs are acquiring serious life threatening health risks through poor diet and vitamin deficiency. If your Australian Shepherd does not reach its life expectancy of 12 years because of a genetic disorder, you will be eligible to get a replacement puppy of better or equal quality. (Hip and elbow x-rays must be completed by 24-36 months of age and certified by OFA for this guarantee).

Option 2 - 2 Year Health Guarantee - This offer is against genetic moderate or severe hip dysplasia, and retinal eye disease. We highly suggest that your puppy continue with Life's Abundance All Stages and Agility Formula for the first 24 months of his/her life in order to qualify for this 2 year health guarantee. If your Australian Shepherd has a genetic disorder before 24 months of age you will be eligible to get a replacement puppy of better or equal quality.

We suggest you contact your veterinarian at the time of delivery and follow their recommendation to vet checks and immunizations. Your puppy has been veterinarian checked by our vet and was found to be in good health at the time of transfer.

If two licensed veterinarians (one being local) identify a genetic disorder the puppy/dog will be replaced by another puppy/dog of better or equal quality. You will need to return the puppy/dog along with its registration papers. Buyer pays all shipping costs incurred by returning the original puppy/dog and receiving the new puppy/dog. **No money refunds will be given.** Veterinarian costs are non-refundable. Should the puppy/dog be sold before 24 months all guarantees are null and void.

It is understood that at the time of the sale this dog is not to be used for breeding, but is representative of its breed and is structurally and temperamentally suited as a companion, agility, working and/or obedience dog. (Based on sellers analysis of the puppy/dog's age, how long the *original* Buyer owned the puppy/dog and whether the puppy/dog has been taken care of properly with respect to its physical and mental health) ASCA registration application will be included in your puppy packet.

Both parents lineage of this dog/puppy has had a full genetic panel of testing and their hips were x-rayed and certified at least “good” by the Orthopedic Foundation for Animals. Although the prognosis is good that pup is cleared by parentage and will not have eye or hip defects, it has not been examined for these and is being sold without certification. The new owner must decide for him/herself whether to pay for these tests.

Buyer agrees to NEVER surrender this puppy to a rescue service or animal shelter, under any circumstance. The buyer agrees to first contact Old-Time Australian Shepherds to get our approval of placement of your Aussie. This includes the sale or placement to any third party. Your Old-Time Aussie is *always* welcome back here.
